RainDance River Resort Rules and Regulations

These Rules and Regulations are designed to promote the safety and enjoyment of members and their guests of the Raindance River Resort (the "Resort"). We ask for your cooperation in abiding by these rules. Decisions of the lifeguards on duty will be final.

Opens Memorial Day Weekend. Closes Labor Day Weekend.
Closing may be extended beyond Labor Day, weather permitting.

Hours of Operation:

Sunday – Thursday: 10:00 am – 7:00 pm

Friday and Saturday: 10:00 am – 8:00 pm

School Days – August 12 – September 4 (weekdays only): 4:00 pm – 8:00 pm

SWIMMERS SWIM AT THEIR OWN RISK AT ALL TIMES

***ALL MEMBERS AND GUESTS MUST COMPLETE A WAIVER OF LIABILITY AND RELEASE FORM
PRIOR TO ADMITTANCE TO THE RESORT.***

CODE OF CONDUCT

1. The Resort is a family facility and all persons shall conduct themselves in a manner consistent with this standard.
2. Members and guests using the Resort must conduct themselves so as not to jeopardize or interfere with the safety, rights, and interests of other persons.
3. No one shall harass or accost any other person, including but not limited to District employees, District Management, or other District representative, lifeguards, and pool staff, and all persons are expected to comply with all requests and demands of lifeguards, pool staff, and District representatives.
4. Members are responsible for the conduct of their guests. All guests of the Resort will be held to the same standard of conduct as Members.
5. Any person failing to abide by these Rules and Regulations, any other stated policy or safety rules as contained in the any of the District's governing documents and/or as posted at the Resort, or direction from a lifeguard or pool staff may be asked to leave and may have their access rights to the Resort temporarily or permanently revoked. The District may also impose fines or penalties for violation of its governing documents.

RAINDANCE RIVER RESORT RULES AND REGULATIONS

Pool Rules:

The lifeguard has complete control over all activities in the pool area, and their instructions must be obeyed. The lifeguard shall have the authority to interpret or enforce these Rules and Regulations, and to remove any person for failing to follow the lifeguard's instructions.

1. Running, horseplay or diving into the swimming pool is not permitted.
2. No conduct detrimental to safety. No pushing/dunking/rough-housing. No Spitting or throwing of water.
3. No breath-holding activities allowed.
4. No hanging on lane lines or depth dividers.
5. No glass containers in the Resort.
6. No outside food or drink is permitted.
7. Food purchased at the Resort is not permitted in or near the swimming pools – only at the supplied tables. Trash must be disposed of in waste receptacles. No gum is permitted.
8. No animals or pets (except service animals) are permitted in the Resort at any time.
9. Persons using the pool are encouraged to shower before entering the pool.
10. Proper swim attire is required in the pool – swim suits only. No cutoffs or shorts. Swim Shirts are allowed.
11. Children who are not toilet trained, or any individuals who are incontinent, must wear diapers designed by a manufacturer for swimming purposes while in the water. No plastic disposable or cloth diapers are permitted.
12. No oil-based products (i.e., suntan oil, baby oil) are allowed in the swimming pool.
13. Foul, abusive, or excessively loud language will not be permitted.
14. Floatation devices are permitted at the lifeguard's discretion. Mermaid tails/fins are not permitted. Coast Guard approved lifejackets, including puddle jumpers are permitted.
15. Hard balls, including but not limited to tennis balls, baseballs, and footballs, are not permitted in the pool.
16. Bicycles, skateboards, scooters, rollerblades, etc., are not permitted within the pool area. Strollers may be brought into the pool area and must be wheel-locked when unattended.
17. Any swimmer under the age of 10 must pass a swim test in order to swim unaccompanied by an adult or responsible person 16 years or older. Swimmers who must be accompanied will be required to wear a red wristband to signal to the lifeguards that they should have a guardian in the water within an arm's reach at all times. Any swimmer not required to pass a swim test but dependent on a floatation device to swim must be accompanied, in the water, by an adult or responsible person 16 years or older within arm's reach.
18. Radios and other electronic devices must be played so as not to offend others. Lifeguards may determine acceptable volume levels.
19. For safety reasons, chairs, lounges, tables, and other items which can obstruct or interfere with access to and from the swimming pool area are restricted to designated areas.
20. No alcoholic beverages are allowed outside designated areas.
21. The pool is subject to being cleared for a 10 minute safety break at 10 minutes to each hour.

22. Any person with an infection, communicable disease, open wound, etc., is prohibited from using the pool facilities.
23. The Resort is a drug-free, smoke-free, and tobacco-free environment. No tobacco, marijuana, smoking (vaping), or drug use is permitted.
24. The District and lifeguards are not responsible for lost or stolen articles or damage to any personal items.

Water Slide Rules:

1. Non-swimmers are not permitted on the slide, including those wearing a red wristband.
2. All riders must be at least 48" tall.
3. Maximum rider weight is 300 pounds.
4. WARNING: Water depth is 3 feet 6 inches.
5. All riders must ride feet first while lying on their back with arms crossed across their chest. Do not go down the slide head first. Do not sit up while riding the slide.
6. Riders must enter the slide in a sitting position and wait for instructions from the lifeguard stationed at the slide starter tub.
7. Do not propel yourself into the ride.
8. Only one rider at a time. Absolutely no trains or chains of riders are permitted.
9. No running, standing, kneeling, rotating, tumbling, or stopping in the flume. Arms and hands must remain inside the flume at all times. Riders should remain in proper riding position until forward motion is terminated. At no time should the rider attempt to stand up while on the slide or prior to coming to a complete stop in the splash out area.
10. No tubes, mats, or life jackets are permitted on the waterslide.
11. Only approved swim suits allowed. No combs or foreign objects are allowed in pockets and no jewelry can be worn while riding the slide.
12. The line should form on the deck with one rider on each landing and one rider in the starter tub. Wait until landing area is clear before entering the starter tub.
13. Riders must be in good health. Elderly persons, those suffering from heart disease, high blood pressure, epilepsy, or persons using prescription medication should consult their physician before using the slide. Individuals with medical conditions including, but not limited to, pregnancy, heart, or back problems should not ride.
14. Do not use this slide while under the influence of alcohol or drugs.
15. No diving from the slide.
16. Leave the landing area promptly.

WARNING:

“Failure to follow water slide rules can result in serious injury.”

Weather Rules:

The District is not responsible for monitoring weather conditions, and each person in the pool area should immediately exit the pool area if lightning or thunder is observed or when directed to do so by an attending lifeguard. The lifeguard has the authority to clear the pool at any time.

1. The feels like temperature outside must be 65 degrees or higher for the pool to open.
2. If lightning or inclement weather is spotted the pool will close for safety and reopen when the weather has passed.
3. The pool may be cleared if rain restricts the lifeguard's ability to see the bottom of the pool.
4. The lifeguard/pool staff will follow the National Lightning Safety Administration's policy on clearing the pool in the event of a thunder or lightning storm.

Parking Area Rules:

Overnight parking of any vehicles in the parking lots around the Resort is prohibited. Recreational vehicles shall not be parked in the Resort parking lots at any time. All other vehicles, including bicycles and motorized scooters, shall be parked only in designated parking areas. Bikes or other vehicles (scooter, etc.) are prohibited from entering the pool areas and may be removed without notice if left on sidewalks or anywhere except designated parking areas. Vehicles shall not be parked in service areas, in front of the doors, in handicap parking spaces, over the curbs, on the grass or sidewalks or along facility access roads. Vehicles parked in violation of the District's governing documents are subject to immediate towing (including costs for towing), fines and other sanctions, including, but not limited to, loss or modification of Resort membership and/or use privileges.

Except for those areas reserved in conjunction with an event booked through the "Resort's Event Coordinator", no areas within the Resort can be reserved and are available on a first come first serve basis, only.
